

**Marriott® HSB Giveaway Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. Subject to all federal, state, and local laws, regulations, and ordinances. Sweepstakes begins at 12:00:00 AM Eastern Time ("ET") on *May 01, 2008* and ends at 11:59:59 PM ET on *June 20, 2008* (the "Sweepstakes Period").
